#### Community Bicycle Recycling Program needs help.

This is a wonderful program that helps bring bikes to children. They are a not-for-profit, volunteer group that recycles bicycles. Recently they lost their storage space, and are looking for some free space in which to store bicycles. Ideally, they would need about 1500 square feet, and larger would be awesome. Currently they have about 60 bikes that are ready to be distributed, and another 200 or so that need to be repaired.

They are a 501 c 3 organization, so if you have some warehouse space, it would be a charitable contribution as well as helping a great cause. Donations of funding, bicycle and bicycle mechanical aptitude are also much appreciated. Check their web page at www.communitybikerecycling.org.

They accept donations of bikes and parts of any age and condition as well as monetary contributions to cover the costs of materials such as tubes, tires, handlebar grips, and seats in addition to recycling (yes, they have to pay to recycle bicycle tires). In addition to bicycles, recipients receive a bicycle helmet.

They are committed to reducing our waste stream and attempt to recycle parts of bicycles that can no longer be safely used. We give bicycles and bike safety and repair demonstrations to public schools and adult groups such as the Endorphin Power Company (for drug rehabilitation programs), and St. Martin's Hospitality Center (for the homeless). They partner with Albuquerque Alliance for Active Living, who are also financial supporters.

## Bernalillo County Emergency Notification System – Reverse 9-1-1

Bernalillo County utilizes an emergency notification system (reverse 9-1-1) which can be used to send important messages to residents and businesses within the unincorporated areas of the County with the capability of sending thousands of messages in a very short time, based on the geographic location of an incident.

Examples of Emergency Notifications may be:

- Evacuation notices due to emergency situations, such as fire, flood or other environmental hazard.
- · Notifications of dangerous situations in your area, such as an environmental hazard, law enforcement investigation or other instance where you may be instructed to remain in your home.
- \* Notifications are NOT automatic and are sent at the direction of an incident commander or other managing authority of a situation.

If you have a landline phone, either residential or business, your phone number has automatically been entered into the system and is capable of receiving an emergency notification.

Emergency Notification Opt-In for Cellular/VoIP (Voice Over Internet Provider) Phones

In our continued effort to improving the safety of citizens in the unincorporated areas of Bernalillo County, Bernalillo County and the Emergency Communications Center (E9-1-1), are pleased to announce you may now register your cellular and/or VoIP phone number(s) for the purpose of receiving emergency notifications.

If your primary phone is a cellular/VoIP phone number and you would like to receive the emergency notification you will need to register the phone number with Target Notification.

Keep in mind once you register your phone number and the Bernalillo County Emergency Communications Department sends out an emergency message, you will receive the notification even if you are NOT in the affected area at the time.

Also, if you change your cellular/VoIP phone number you will need to re-register it.

#### President's Column - Steve Wentworth

The next general meeting of ANVA should be interesting. We will have Bernalillo County (Bernco) updates from our Commissioners and Bernco representatives. We have invited the Bernco Sheriff's Dept. NV Commander, Lt. Claire McCarthy and Bernco Fire Chief John Garcia. Neighbors have had cars broken into - a gun was fired thru a truck in a residential neighborhood, theft problems and so forth. Traffic is always an issue and this meeting will allow folks to express their concerns and maybe get some solutions. The fire season is here and Chief Garcia has the huge job of trying to keep Bernalillo County safe.

**County Commissioners imposed fire restrictions** on open burning and fireworks outside the city limits of Albuquerque, in the unincorporated areas of Bernalillo County.

The following are not allowed due to the fire restrictions: Agricultural burning, bonfires, burning of explosives, campfires, ceremonial fires, cooking fires, hot torch burning, ignition of rocket motors, open burning, open flames, slash piles and burning weeds. Charcoal broilers, barbecue grills, wood and coal burning stoves used outside of private dwellings are classified as campfires and are prohibited.

The fireworks restrictions apply to the sale and use of any fireworks that shoot sparks and pieces outside a six foot circle and/or higher than 10 feet in the air or are louder than a cap gun. Fireworks that may pose a hazard by falling or tipping over during operation are also restricted.

### Violators who are cited could face fines up to \$300 and/or 90 days in jail.

Albuquerque has restrictions on things that fly or explode - not sure what Los Ranches and Rio Rancho will do. State law allows local jurisdictions the power to restrict the use of fireworks and to ban certain fireworks during droughts. However, local officials must hold a public hearing and issue a proclamation for a ban at least 20 days before a holiday for which fireworks can be sold. The governor has twice tried and failed to pass a state law aimed at allowing for cities, counties and the state to easier ban fireworks during extreme drought. It is a shame that the law did not pass.

Los Ranchos Rd construction is scheduled to begin Monday June 18, and will continue until July 18. The Bernco Public Works Division will begin roadway improvements on Los Ranchos Rd from Edith to the county limits, just west of 2nd Street. Alameda Trail - Edith Blvd. continues to be closed and lanes continue to be blocked occasionally on Alameda Blvd. Bernco Public Works said Edith would be closed May 9, 2012, at Alameda for 4 weeks – we guess there have been problems because it is still closed. Bernco Public Works Department and the Bernco Public Information Office continue to do a terrible job of communicating with the public about the project.

The Alameda/North Valley community worked with NMDOT when Alameda Blvd. was widened to make the project better. Areas along the south side of Alameda were saved for an open space trail area. Trees were saved and additional landscaping was put in to make the area attractive for future generations. The trail was added as a functional and positive addition to the project. Concrete was colored a brown earth tone and was designed to meander through the area instead of in a straight manner that would not be appealing to people using it. The earth tone colored concrete was used in the entire project as a means to set the project apart

and give it some character.

Many of the items the community worked for to enhance the area were ignored. Asphalt – black trails were installed that were almost straight and certainly did not complement or match the trails on the rest of the project. The designs of the existing brown concrete walks were ignored. New concrete sidewalks at intersections were installed next to existing earth tone walkways. Regular white/gray concrete was used and it makes the project appear as if no planning was given to the project.

Did the Bernco Public Works Department and the Bernco Parks and Recreation Department have a reason for ignoring what was done in the past with community support? Was there no concern or planning given to the aesthetics or the continuity of the project? It would be logical to most people to continue the type of design that was originally implemented for the rest of the project. I believe the community is pleased that the project is finally going to be completed.

It is very sad that Bernco Public Works Department and the Parks and Recreation Department decided to ignore the obvious and the initial planning that was done for Alameda Blvd. by the community and NMDOT.


